

City of Birmingham

- Britain's second city, Population of over 1 million
- Central location, Close to London
- Good transport links, international airport
- Multi-cultural city, 30% ethnic minorities, 40% under 25 years, 100+ languages spoken across the city
- First class Arts venues, excellent shopping
- Host to international music and sporting events (hosted the Commonwealth Games 2022)







University of Birmingham

- Founded 1900 / Russell Group
- First Campus University.... Opened 1909. 276acre green parkland around the University.
- **£500million** recently invested to produce a new Library, a new Sports Centre, and the Green Heart.
- **Global University**...34,000 students, 5,000 overseas students from 150 countries.
- **Top 100** university (QS World University Rankings)
- 30+ Korean students currently on Government funded scholarships (MA Global Public Policy)
- One of the **top 5 universities** in the UK that major companies target













- Public Policy all the policies of government.
- Social policy quality of life issues that affect the overall welfare of citizens.
- Draws on economics, sociology, psychology, geography, history, law, philosophy and political science.



Social Policy can make a Difference


Change - can take place at:



MA Global Public Policy

- Seeks to understand the ways that policy is formulated within social, political, economic and históric contexts.
- 20-week work internship option (MA Global Public Policy with Integrated Placement - 21-month programme)

- Global Public Policy Institutions and Networks
- **Policy Evaluation**
- Poverty, Wealth and Inequality Applied Qualitative and Quantitative Data Analysis
- Dissertation (12,000 words) 60 credits

MA Social Policy

The study of social problems e.g. poverty, homelessness, substance use, crime, health inequalities.

Consider the underlying causes and to formulate policy solutions to address social problems.

Modules include:

- Globalisation, International Migration and Citizenship
- Sociology of Race and Racism
- Transforming Identities
- Dissertation



MSc Public Management

- Based in the School of Government.
- Provides an opportunity to develop an understanding of governance and the challenges of improving performance and co-ordinating public services.

 - Public Policy & Evidence



The Dissertation

- Choose a topic of your choice.
- Formulate a research question.
- Answer that question using your own research.
- Use primary research (e.g. your own questionnaire survey, interviews)
- Use secondary research/data
- 12,000 word limit



Examples of Research Questions

- How can housing policy reduce poverty among low-income people?
- How do the UK and Korea measure and reduce fuel poverty?
- How does maternity leave and childcare policy affect female employment rates in Sweden and the UK?







Support with your Dissertation

- One year MA dissertation from April-September
- Dissertation workshops throughout the year
- Dissertation supervisor expert in your discipline (where possible)
 - Helps to formulate your research question
 - Organise structure
 - Helps you find data/literature
 - Comments on a dissertation draft
